## 12. First Information contents:

Duplicate Tahrir in Hindi, In the service of Police Station Incharge, Rajpur Dehradun. 24/5/24 Applicant Ranbir Singh Sahni, son of Satendra Singh Sahni, resident of 119-D Race Course, I humbly request that the father of the applicant, Mr. Satendra Singh Sahni, a Mr. Ajay Kumar Gupta, son of Mr. Shiv Gupta, resident of 7 Nehru Road, Dalanwala, Dehradun and Mr. Anil Kumar Gupta, son of Shri Shyamlal Gupta, resident of 7 Nehru Road, Dalanwala, Dehradun, was being continuously black mailed and threatened. In this sequence, a detailed complaint was given by the father of the applicant to the local police on 16.05.23 in which he informed the police regarding the acts, threats, harassment and blackmailing being done by the above mentioned Mr. Anil Kumar Gupta and Mr. Ajay Kumar Gupta. The above mentioned Anil Kumar Gupta and Ajay Kumar Gupta were pressurizing my father to transfer both the projects in their name and had expressed fear of danger to life and property of himself and his family. In this sequence, Mr. Anil Kumar Gupta and Mr. Ajay Kumar Gupta. Using his influence, a false complaint was given to the police in Saharanpur without any area authority on the basis of his false address and forged forms. Due to which my father was being called there repeatedly by the police and the police had given him time till today morning to appear due to which he was very nervous and during this time he was continuously receiving threats from the Gupta brothers. Till then, put both the companies in my name, otherwise you should be ready for your son-in-law to go to jail or it will create such a situation that you yourself will commit suicide. You have already seen our impact. He was extremely troubled by the daily harassment, insults and threats and was also very nervous due to his son and son-in-law's name being falsely implicated. This morning my father left the house at around 9 o'clock without informing me and after some time I It was learned that he had committed suicide by jumping from the eighth floor of Pacific Golf on Sahasradhara Road. A suicide note was found in his pocket. The suicide note also mentions the threats, blackmailing and harassment being given by Anil Kumar Gupta and Ajay Gupta towards my father. My father has been instigated to commit suicide by the above mentioned persons. Therefore, it is a humble request to you sir to please register my report and provide me justice and also provide security to our family.
